To the Auditor:

Three sets of "election returns" blanks are herewith transmitted for your use in making up the abstract of the vote of your county for the Initiative Measures, Referendum Bill, Constitutional Amendments, Congressional, State, District and County Officers and the certified copies thereof required by law, to be returned to this office.

ONE SET is intended to be used, if you so desire, in making up your original abstract of votes to be retained in your office.

THE SECOND SET should be used in preparing a certified copy of your original abstract of votes for the Initiative Measures, Referendum Bill, Constitutional Amendments, Congressional, State, District and County Officers, for filing in this office. This set must be full as to all offices named in order that the vote for the Initiative Measures, Referendum Bill, Constitutional Amendments, United States Senator, Congressmen, Supreme Court Judges, etc., may be canvassed and certified by this Department to the Governor as required by law, and the vote as to all National, State and County Offices put in tabular form for official report by the Secretary of State.

THE THIRD SET should be used in preparing a certified copy of the original abstract of the vote for Governor, Lieutenant Governor, Secretary of State, State Treasurer, State Auditor, Attorney General, Superintendent of Public Instruction, Commissioner of Public Lands and State Insurance Commissioner, as required by Section 4 of Article 3 of the State Constitution. This set should be enclosed separate from the returns above referred to, and having been securely sealed and endorsed "Election Returns for State Officers," transmitted by registered mail to this office. These returns are required to be delivered, with seals intact, to the Speaker of the House of Representatives by the Secretary of State.

TWO mailing tubes are forwarded herewith for your use in transmitting the certified copies of the Abstract to this office.

The Attorney General sanctions the form of the certificate printed on the back cover of each set, which is provided with the view of securing uniformity.
