1. CALL TO ORDER

Chair Larry Dennison, called the meeting to order at 2:05 p.m. and stated that a quorum was present.

Chair Larry Dennison offered congratulations to Kevin Streett as the new General Manager for the Jefferson County PUD.

2. <u>CAB/STAFF INTRODUCTIONS:</u> CAB and staff introduced themselves.

3. <u>ANNOUNCE CHANGE IN CAB MEMBERSHIP:</u> Chair Larry Dennison announced that Tim Tibbals, District 2 representative had resigned and Jessica Dillon was introduced as the new CAB member for District 2.

4. <u>**REVIEW OF AGENDA/APPROVAL:</u>**</u>

MOTION: Russ Michel made a motion to approve the Agenda as presented. Karen Bennett seconded the motion. Motion carried unanimously.

5. <u>PUBLIC COMMENTS (for items not on the agenda) – topics:</u>

6. <u>SIGN AND APPROVE CAB MINUTES</u>:

Meeting minutes of March 8, 2019, were signed.

Corrections to CAB Minutes of April 8, 2019:

- Page 4 of 8 should be a \$ in front of 4.3 million.
- Page 3 last bullet on 9.1 Broadband Subcommittee question word "oriented". Should it be there?
- Section 9.2 "Michell" should be "Michel".
- Section 9.2 fourth bullet down April 2, 2009, the BOC approved the recommendations of the two procedural changes. When the commissioners make a BOC report those are spelled out in detail.
- Section 9.2 sixth bullet down "commissioners" instead of commission.
- Section 9.2 committee should be sub-committees.
- Public comment Dan Taylor was "asked to be on" the sub-committee -instead of was "asked to be on".

CAB members requested that the minutes be sent out as soon after the meeting as is possible.

7. <u>BOC UPDATE – DAN TOEPPER:</u>

- Kevin Streett was offered position of General Manager.
- May 1st survey launched on broadband.
- 10-12 positions need to be filled at PUD. Meeting later this month.
- Strategic plan will be updated in coming month.
- Liz Anderson from WPUDA will be at the PUD on May 21st.
- Policy was passed by the BOC that requires employees live within service area.

8. <u>PUD STAFF REPORTS – KEVIN STREETT:</u>

- May 21st financial public hearing may not happen.
- Outreach to Fire Departments.
- Training with Fire Department on safety is May 29th and 30th.
- Staff working through issues on audio recording index.

9. <u>SUB-COMMITTEE REPORTS:</u>

<u>9.1 Broadband Sub-Committee – Karen Bennett:</u> CAB member Karen Bennett gave a report.

- Internet survey did get launched and went out in PUD bills and there have been articles in both the local paper and the PDN.
- Jefferson Broadband Action Team (JBAT) has been active.

Gary Rowe gave a short report on JBAT.

- Next meeting scheduled for May 16, 2019 at 3:30 p.m. at the Chimacum High School Library.
- The focus is: What is the bigger issue for broadband for the community in conjunction with what the PUD is doing under their own strategic plan?
