The regular Board of Commissioners (Board) meeting of Public Utility District No.1 of Jefferson County (PUD) was called to order by the President of the Board at 5:00 p.m. on January 3 2017 at 230 Chimacum Road, Port Hadlock, Washington. Attending:

Changes to December 13 2016 regular Board meeting minutes:

- Pamela Browning's questions regarding names, Port Townsend Paper charges, and taxing districts were answered and the minutes so amended.
- Page 3: last paragraph: "Limited Utility District" corrected to "Local Utility District". MOTION: By Commissioner King, seconded by Commissioner Randall, and unanimously carried: to approve the minutes of the following meetings:
 - Regular Meeting of 13 December 2016, with changes;
 - Special Meeting of 13 December 2016, as submitted.

Financial Director Report:

Kim Younger will present the December 2016 month-end report at the first regular Board meeting in February 2017. She distributed and briefly reviewed the *PUD December 2016 / Year End Closing Schedule*.

She confirmed the State Auditors will hold the 2015 Exit Conference, a public meeting, on February 7 2017 at 3:00 p.m. Commissioner King requested Moss Adams review the 2015 financial reports. Kim will work with Tammy Lehman, District Interim Chief Financial Officer, to involve Moss Adams in the review - in a similar fashion as in previous years.

Kim reported on the research she has done to clarify why the budget billing plan is not used by all low income customers.

Payroll and Vouchers Review and Approval:

MOTION: By Commissioner King; seconded by Commissioner Randall; and carried unanimously: to approve the *Voucher Approval Form* dated 3 January 2017, as presented by Kim Younger, in the amount of \$3,483,490.57. This includes vouchers:

Items from the Floor, not listed on the Agenda:

- Leo Boyd addressed the Board regarding his problem with perceived over-charges by NoaNet. Jim Parker distributed PUD Resolution No. 2016-017, which established the PUD's telecommunications network and network access charges for dark fiber and a copy of Joel Paisner's email on this topic. Jim Parker and Kevin Streett will contact Joel Paisner to help resolve the issue. Commissioner Randall offered to continue the discussion outside the Board meeting.
- Leo Boyd expressed concerns regarding erroneous internet service hook-up quotes given to potential customers. The quotes apparently originated with the Port of Port Townsend or the Transit Authority.
- Norm Norton offered commentary regarding broadband access in outer Jefferson County. Commissioner King recommended pressure be brought to bear on State Legislators to allow public utility districts to provide end-user service.
 Commissioner Collins offered to continue the discussion outside the Board meeting.
- United Good Neighbors of Jefferson County (UGN) presentation: Nikki Russell gave a slide show overview of the organization's work and how it serves county residents. She asked the PUD to implement a payroll deduction to help fund UGN - that deduction option is already in place.

Commissioner Reports:

The Commissioners reported on meetings and events they attended, and those they plan to attend, on behalf of the PUD.

Action Items:

- 2017 PUD Board Positions, Washington Public Utility Association (WPUDA) and Other Representation: The Board reviewed the proposed 2017 assignments, including:
 - Public Power Council: Commissioners rotate attendance.
 - Energy Northwest: Commissioner Collins.
 - PUD Citizen Advisory Board: Commissioners rotate attendance.
 - North Olympic Peninsula Resource Conservation and Development Council: Commissioner Randall.
 - WPUDA Education Committee: Commissioner Collins, with Commissioners King and Randall as alternates.

MOTION: By Commissioner Randall, seconded by Commissioner Collins, and unanimously carried: to approve the proposed 2017 PUD Board, WPUDA and other Board assignments as submitted.

Jim Parker will notify WPUDA of the assignments.

• <u>Transformer Purchase Bids</u>: The Board reviewed the *Preliminary Bid Tabulation* and the PUD policy regarding equipment purchases. Kevin Streett will provide the Board with the number of transformers of each type to be initially purchased.

MOTION: By Commissioner Randall, seconded by Commissioner King, and unanimously carried: to approve the low bids for a year's worth of overhead and pole mounted transformers to General Pacific-Howard and General Pacific-Ermco, as described in the documents provided to the Board.

Rick Hughes recommended the PUD review and, if necessary, update its procurement policy.

<u>Discussion Items</u>: The Commissioners, PUD staff and consultants discussed several topics:

- <u>Team Jefferson Service Proposal</u>: Reviewed limits and processes related to personal and professional service contracts. Jim Parker will gather more information and bring it to the Board for discussion.
- Resolution 2017-001: Retired Commissioner Barney Burke: Distributed the draft resolution recognizing Commissioner Burke's service. The Commissioners will review the resolution and send any suggested changes to Jim Parker.
- <u>Meter Replacement Strategy</u>: Discussed the meter replacement deployment timeline, pedestal replacement policy, and customer communication. Commissioner Randall will work with Debbie Lund to develop a draft communication plan.
- Resolution 2017-002: Low Income Program: Distributed a draft resolution adopting low income reduced rates. Discussed:
 - Program implementation timeline,
 - Coordination with other organizations involved in providing assistance,
 - Communication with customers,
 - Legal implications of using Olycap low income certification,
 - Commitment to continue studying program implementation and process making revisions as needed.

Commissioner Randall suggested the Board consider convening a working group of PUD Citizen Advisory Board (CAB) members and representatives from Olycap, Saint Vincent de Paul and other key organizations - to meet with Michael Karp, with the "Energy Project", and develop an overall low income assistance plan. Commissioners King and Collins preferred to adopt a low income rate program as soon as possible.

The Commissioners will review the resolution and send comments to Jim Parker for review at the next regular Board meeting.

- Brinnon Telecom Request: Reviewed the request for financial assistance to implement a wireless broadband system. Commissioner King suggested the PUD ask local Planning Commissions to require communications conduit installation for new construction projects.
- Resolution: Water Meters and Encoder Receiver Transmitters (ERT) Purchase: Briefly
 reviewed the draft sole source purchase resolution. Jim Parker will finalize the
 resolution and bring it to the Board for review/approval at its next regular meeting.
- <u>East Jefferson Fire District Proposal Update</u>: Rick Hughes has contacted the Fire District's General Counsel and the Jefferson County Prosecuting Attorney to arrange a meeting between the three parties to discuss the issue.

<u>CAB Report</u>: Don McDaniels reported.

Commissioner Collins will attend the January 9 CAB meeting. There are three openings on the CAB, which are being advertised. Currently-sitting members will continue to serve until replaced.
