### 1. CALL TO ORDER:

Commissioner Kenneth Collins called the public hearing on the Jefferson County PUD Budget for 2018 to order at 5:00 pm. Purpose of the hearing was to take any testimony and answer any questions from the public on the budget and then to reconvene.

### 2. PUBLIC HEARING ON BUDGET:

Kevin Streett, Assistant General Manager, goes over the budget material and referenced the process going forward.

Budget has to be adopted by the end of November, 2017. If the budget was not adopted by the end of November, there would have to be a special meeting.

The budget and the rates don't necessarily go together. The rates for the new budget do not have to be adopted at the same time the budget is adopted.

Both the rate and budget presentation are on line.

There will be one or more hearings on adopting the rates.

**MOTION:** Commissioner Jeff Randall moved to close the first public hearing, and Commissioner Wayne King seconded that motion. Motion carried unanimously.

#### **PUD REGULAR BOARD MEETING**

### 1. <u>CALL TO ORDER:</u>

The November 7, 2017, Regular Meeting of the Jefferson County PUD which, because of its location, is also a Special Board Meeting was called to order by Commissioner Kenneth Collins at 5:05 p.m.

### 2. <u>AGENDA APPROVAL</u>:

**MOTION:** Commissioner Jeff Randall moved to approve the agenda and motion was seconded by Commissioner Wayne King. Motion carried unanimously.

3. ITEMS FROM THE FLOOR: The Homeowners' Association of Kala Point has formed a Fire Hydrant Safety Committee. People have observed that store fittings are appearing on water hydrants. The committee wanted to convey to the PUD their appreciation for the work they have been doing on the fire hydrants. On many of the hydrants but not all of them there is a red disk. Kevin Streett responds that the red disk means to the fire department the gallons permitted at that hydrant so that they know how much fire flow there is. The PUD is in the process of mapping and putting labels on all the hydrants. Eventually all of the hydrants will have some kind of color code. The PUD is in the process of bringing a contractor in to do fire flow testing.

The committee asked if it would be possible for one of the PUD staff members of the water system to come and visit the Fire Hydrant Safety Committee. Kevin Streett said that would be possible.

An update on the broadband strategy was requested. PUD is working on this.

Question was asked if anything had been done about the generator not starting. Kevin Streett is talking with NoaNet and there are plans moving forward. Some things have been put into place such as an emergency contact for NoaNet. In the short term the generator could be started and the PUD is looking at other short term options. Long term options are being put in place also.

### 6. <u>ACTION ITEMS REQUIRING BOARD DISCUSSION:</u>

6.1 AMI Project: Assistant General Manager Kevin Streett gave a report. The plan for the next couple of board meetings is to revisit the AMI meters. The PUD would like to explain where it is coming from and try to move the project forward. Today's discussion is to talk about the RFP and the bids we got back from various people who provide AMI meters

and/or meter installation. When the bids were sent out ITRON was low bid. Staff contacted ITRON.

Assistant General Manager Kevin Streett gave some information on the power line carrier. He will present more information at the next Board meeting.

There were some questions from the public and the commissioners on the AMI project.

6.2 Lot purchase at 210 Four Corners Road: Assistant General Manager Kevin Streett requested the approval of the commissioners to continue to explore the possibility of the PUD purchase of a lot across the road as a buffer. Commissioner Jeff Randall requested a map of the lot be provided to the commissioners.

**MOTION:** Commissioner Wayne King made the motion to give authorization to the Assistant General Manager to start negotiations to purchase the lot purchase at 210 Four Corners Road. This motion was seconded by Commissioner Jeff Randall. Motion carried unanimously.

- **6.3** Radio Interlocal Agreement: Kevin Streett, Assistant General Manager would like to move forward with the radios. He stated he would have an interlocal agreement at the next regular PUD meeting.
- 6.4 Options from MYCOFF: Consultant Don McDaniel gave a brief report on the process and what steps are next in the selection of interviewing candidates for the recruitment for a new General Manager. He outlined some options that are available and made his recommendation which was to go with Option 3. It gives a more extended time line. Commissioner Kenneth Collins was given the suggestion to solicit from the public some of the criteria for the selection of a General Manager. The commissioners gave direction to Don that they would like to revisit what was earlier developed, refine that, ask for input from the public in terms of the selection criteria and integrate that so that they can be part of the process in interviewing the various candidates. Any selection process has to be done in an open public meeting.

**MOTION:** Commissioner Jeff Randall made a motion that Option 3 from the Mycoff options be selected. Motion was seconded by Commissioner Wayne King. Motion carried unanimously.

6.5 Facilities options, including possible action regarding the Union Bank purchase and sale agreement. Kevin Streett commented that the decision on whether the Board cancel the escrow money or move forward with the option on Union Bank had to be done at this meeting.

There was discussion on the Union Bank renovation and its durability and the options available to the PUD.

**MOTION:** Commissioner Jeff Randall made a motion that the Jefferson County PUD invokes its right to get its money back on the Union Bank building and direct the architects to pursue Phase 1, Option C, Alternative 2 of the Facilities Plan. Motion was seconded by Commissioner Kenneth Collins. Motion carried unanimously.
