Commissioner Kenneth Collins stated that the purpose of the meeting was to discuss the 2018 PUD Budget.

Assistant General Manager Kevin Streett and Susan Carter, Chief Financial Officer, presented the proposed budget.

There was considerable discussion on the proposed rate increase. Commissioner Jeff Randall has volunteered to be on the Citizens' Advisory Committee that will research the rate increase issue and report back their findings to the Board. Commissioner Jeff Randall specifically stated that he was just facilitating the CAB meeting.

Commissioner Kenneth Collins mentioned that the proposed budget did not mention additional facility improvements. Susan Carter, Chief Financial Officer stated there was \$50,000.00 in the budget for facility improvements. Commissioner Collins stated that the improvements to the facility at 230 Chimacum Road in Port Hadlock needed to have priority status.

There was discussion on a new venue for the PUD meetings. Assistant Manager Kevin Streett will look into possibly having the meetings moved to the Jefferson County Transit Facility across the street from the PUD Operations Facility on Four Corner's Road in Port Hadlock.

All three commissioners stated their appreciation to Susan Carter and Kevin Streett for the format of the proposed budget which was easy to read and understand.

A public hearing for the budget will need to be set. Assistant General Manager Kevin Streett will schedule.

There was some discussion on the brush cutting and tree trimming from the public forum.
