Subcommittee appointment process:

Resolution 2018-015 Sec. 2(C):

...CAB members volunteer to be on a subcommittee based on their area of expertise or interest. A subcommittee shall not constitute a quorum of the CAB. Based on unanimous approval by subcommittee members, a subcommittee may invite non-voting members of the public to participate.

## Operating guidelines:

Formation: When a subcommittee is formed, CAB members indicate their willingness to participate. The CAB chair shall have the final say in the subcommittee membership taking into consideration CAB member topic expertise, balanced representation from each PUD commissioner district, and balancing out overall member participation.

Recommendation of workplan committee:

- Each new subcommittee will prepare a statement of work outlining the issues they will be discussing and potential policies to be developed. The statement of work will be presented to the CAB for discussion and input.
- Each existing subcommittee will prepare a summary of what they have previously worked on, their accomplishments, their current work plans and goals to ensure new members are able to fully participate in subcommittee work. New members will study prior subcommittee work to be fully informed on their topics.
- Subcommittee summaries will be placed in onboarding materials for new CAB members.
