RESOLUTION NO. 2021-003

A RESOLUTION of the Board of Commissioners of Public Utility District (PUD) No. 1 of Jefferson County, Washington, ordering the Segregation of an Assessment on the Assessment Roll of Local Utility District (LUD) No. 3.

WHEREAS, Resolution 89-285 and Resolution 89-290 which amended and reconfirmed 89-285, adopted March 1, 1989 and April 5, 1989 respectively, has levied and confirmed assessments for Local Utility District (LUD) No. 3; and

WHEREAS, Dan Nasman, on behalf of the Ocean Grove Lot Owners Association, requested that the PUD transfer two water connections from the Ocean Grove Lot Owners Association account held under parcel number 977100308 as follows: 1) one water connection to parcel number 001322031(S32 T30N R1W TAX 2(LS PTNS TAX 92 & 93)) and 2) one water connection to parcel number 977-100-835 (Ocean Grove Estates #2, Block 8, Lot 33); and

WHEREAS, currently the Ocean Grove Lot Owners Association has 13 water system taps held under parcel number 977100308. Therefore, after this segregation of assessment, parcel number 977100308 will have a remainder of 11 water system tap assessments; and

WHEREAS, the Ocean Grove Lot Owners Association understands that by transferring the assessment from one parcel to another will mean that the assessment and water connections have been transferred.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Public Utility District No. 1 of Jefferson County as follows:
