MOTION: Jessica Dillon made a motion to approve the agenda as amended. Larry Dennison seconded the motion. Motion carried unanimously.

4. <u>PUBLIC COMMENTS</u> (for items not on the agenda) – topics: No members of the public were present.

5. <u>SIGN AND APPROVE CAB MINUTES:</u>

Russ Michel made the following changes to the minutes of January 13, 2020:

• Under PUD Staff Reports, Item 7, first bullet, change the word "cancelled" to "postponed".

- Under PUD Staff Reports, Item 7, third bullet, add language "Any staff reports that are going to be given out in a subcommittee meeting will be given to all three commissioners prior to the subcommittee meeting".

6. BOC UPDATE – DAN TOEPPER:

Commissioner Dan Toepper gave a report – topics abbreviated:

- Staff and BOC consulted with Moss Adams.
- BOC attended WPUDA since last meeting. Spoke with legislators about different legislation that is going to be taking place affecting the PUD.
- BOC approved a resolution to suspend a scheduled rate increase for the schools in Jefferson County.
- New job descriptions for the positions of Power Director and Operations Manager are being processed.
- BOC is reviewing an updated Tree Trimming Vegetation Management Plan prepared by Scott Bancroft, Special Projects Coordinator.
- There is a broadband meeting scheduled with Kitsap PUD, NoaNet and TMobile on February 25, 2020, at the Port Townsend Fire Station from 1:30pm to 3:30pm. RSVP if you are planning on attending.
- The PUD staff and the BOC will be reviewing the final draft of Revised Procurement Manual/Policy at the end of February.
- NoaNet contract takes effect March 1, 2020.
- There will be a Public Infrastructure Committee meeting later this month.
- A Joint CAB/BOC meeting will be scheduled soon.

PUBLIC UTILITY DISTRICT No. 1 OF JEFFERSON COUNTY LOW INCOME CUSTOMER RATE REDUCTION PROGRAM.

Low Income Customer: A "low-income customer" is a PUD utility customer whose gross household income does not exceed one hundred twenty-five percent of the Federal Poverty Guidelines (PPG) as published by the U.S. Department of Health and Human Services and as verified by Olympic Community Action Programs (OlyCAP) using their guidelines for the Low Income Heating Energy Assistance Program (LIHEAP).

low- income customer whose completed application has been approved by OlyCAP is eligible for the following rate reductions:

Residential Electrical: \$35.00 per month

Residential Water: 30% of Base

Charge Residential Sewer: 30% of Base

Charge

Low Income Senior Customer: A "low-income senior customer" is a person who is 62 years of age or older and whose total household income after allowable deductions does not exceed the limits prescribed by RCW 84.36.381(5)(b)(ii) senior citizens. A low income senior customer whose completed application has been approved by OlyCAP is eligible for the following reductions:

Residential Electrical: \$20.00 per month

Residential Water: 30% of Base

Charge Residential Sewer: 30% of Base

Charge

Qualifications: To qualify for the program a PUD utility customer must make application for the PUD Low Income Customer Rate Reduction Program to OlyCAP.

A Low Income Senior can qualify for the Low Income Customer rate if they meet that criterion. Once approval is recommended by OlyCAP, the customer will automatically be enrolled in the program for a period of eighteen (18) months. A customer can only qualify for one of the classifications at a time.

Renewal: Following OlyCAP approval, the PUD utility customer will automatically be enrolled in the PUD Low Income Customer Rate Reduction Program for a period of eighteen (18) months after which they will be dropped from the program unless they have gone through the application process again and have been re-verified by OlyCAP.

Place of Use: Qualified utility customers can only apply the low income rate to their primary residence (single water/electric meter).

High Usage. Unreasonably high electric or water usage for a residential home, use of electricity or water for business or business-like purposes, multiple accounts, or other extraordinary circumstances may disqualify a customer from receiving a reduction.

Filing Period: Customers can file at any time for this program. The customer must apply through OlyCAP.

Change of status Report: Ifincome status changes, a report much be filed with the PUD. **Budget Billing Program.** All eligible PUD customers are encouraged to participate in the PUD's Budget Billing Program.

Appeal on Denial of Claim: If the applicant does not meet the qualification as provided by PUD's guidelines, the application can be appealed through OlyCAP and under its process for handling appeals.

Exhibit "A" of Resolution 2017-002, the Public Utility District No.1 of Jefferson County Low Income Senior Customer Rate Reduction Program states the following:

Low Income Senior Customer: A 'low-income senior customer' is a person who is 62 years of age or older and whose total household income after allowable deductions does not exceed the limits prescribed by RCW 84.36.381(5)(b)(ii).

Those RCWs state all or in part (relevant parts included here):

RCW 84.36.381(5)(b)(ii) A person who otherwise qualifies under this section and has a *combined disposable income* equal to or less than income threshold 1 is exempt from all regular property taxes on the greater of sixty thousand dollars or sixty percent of the valuation of his or her residence;

RCW 84.36.381 (2) ... For purposes of this subsection, a residence owned by a marital community or state registered domestic partnership or owned by *cotenants* is deemed to be owned by each spouse or each domestic partner or each *cotenant*...

RCW 84.36.381(4) The amount that the person is exempt from an obligation to pay is calculated on the basis of *combined disposable income*, as defined in RCW 84.36.383.

RCW 84.36.383 (6) "Cotenant" means a person who resides with the person claiming the exemption and who has an ownership interest in the residence.

(Italics and bold CAB emphasis)

Jefferson Count Public Utility District Customer Service Policy

10.6.2 - Senior Low-Income Rate Reduction Program

Any Customer who is over the age of sixty-two (62) and whose household annual adjusted gross income is less than or equal to thirty thousand dollars (\$30,000) per year, will be eligible to receive a low-income discounted rate on their Jefferson County PUD No. 1 electric, water, and sewer accounts.

Senior Low Income Program

What will I receive if I qualify? Qualifying low-income senior customers can receive a \$39.50 per month credit on their electric bill and, if they have water and/or sewer services from the PUD, 30% off the base charge for residential water and/or sewer services.

<u>Do I qualify?</u> For customers 62 years of age or older, the combined disposable income for an applicant, their spouse and/or anyone occupying the residence may not exceed the limits prescribed by RCW 84.36.381(5)(b)(ii). This limit is currently \$30,000 per year. The language from the RCW can be found by clicking here.

<u>What is "Combined disposable income"</u>? "Combined disposable income" means the disposable income of the person claiming the exemption, plus the disposable income of his or her spouse and the disposable income of each individual occupying the residence.

"Disposable income" means "adjusted gross income" as defined by the Federal Internal Revenue Code as amended, plus certain nontaxable income as defined by RCW 84.36.383. Adjusted gross income is an entry on the IRS 1040 form. More information can be found on the application form which will be available soon.

EXAMPLE of differences in how household income is determined by the Washington State Property Tax Exemption Program and the Jefferson County PUD No.1's Low-Income Senior Rate Reduction Program.

Additionally, Jefferson County PUD No.1 Low-Income Senior Discount Program applies to renters as well as homeowners. Due to these discrepancies, the Jefferson County PUD No.1 Citizen Advisory Board recommends that the Jefferson County PUD No.1 Board of Commissioners amend 'Exhibit A' of Resolution 2017-002 to remove the reference to RCW 84.36.381(5)(b)(ii).
