### **Final Minutes**

The Regular Meeting of the Public Utility District No. 1 of Jefferson County (PUD) was called to order by the President of the Board of Commissioners (Board or BOC) at 5:00 p.m. on May 18, 2021. The meeting was held remotely via Zoom. Present:

# 1. CALL TO ORDER:

Commissioner Dan Toepper called the regular meeting of the Jefferson County PUD No. 1 Board of Commissioners for May 18, 2021, to order at 5:00 p.m.

Commissioner Dan Toepper began the meeting by reading the Governor's Extended Proclamation 20-28. A roll call was taken. All three commissioners were present. A quorum was established.

**5. ELECTRIC RATES PRESENTATION/RESOLUTION.** General Manager Kevin Streett introduced Sergey Tarasov, Project Manager from FCS Group who presented the Electric Rate Study Update. #### **Public Comments:**

• **Question.** The residential customers use about 55% of the electricity but provide about 52% of the revenue over the course of the year that is a 4-million-dollar subsidy to the other customers who use the same distribution system as the PUD does. How do you define equity?

**Response:** There are cost based methodologies for establishing equity and energy that is not the only driver of cost allocation. A lot of the costs are fixed, such as customer billing, and meter reading. Those are fixed costs Using electricity as a general allocation in comparison for revenue collection is not always appropriate.

#### **Public Comment:**

• **Question:** It looks like the interruptible primary school rates are going down. Is that correct?

**Response:** That is correct. If we look at the proposed plan based on prior policy discussions, interruptible school class was very close to cost service but slightly below, so the discussion direction received was to keep them flat at zero percent. Because they are currently pretty much very similar in terms of fixed cost structure type of customer as the primary general customer, we wanted to keep their fixed charges consistent tracking with the primary general service. Because we are increasing the basic charge slightly, with that overall, across the board adjustment, and we are keeping the demand charge flat and keeping revenue neutral, one variable will have to go down which was the energy rate. It is a very fractional adjustment, but it is just to make the math work to be at zero neutral combined impact.

All three commissioners were comfortable with moving forward with the revised rates. At the next meeting there will be an Exhibit A to the resolution submitted.

## 6. <u>MANAGER AND STAFF REPORTS</u>:

- New CEO of NoaNet is Craig Nelson.
- There was a request from the public to point out to the ICG that the PUD is putting a large water tank in Quilcene for fire flow investment.

**6.5 Don McDaniel: CAB Report.** PUD Consultant Don McDaniel gave a CAB report. The CAB is back in service. CAB President Jessica Dillon gave a brief update. There was some discussion on a joint meeting with the PUD BOC and CAB. Commissioner Dan Toepper was scheduled to attend the next CAB meeting as a representative of the PUD BOC. **6.6 Will O'Donnell: EEI Transfer Payment from Whatcom PUD.** Communications Director Will O'Donnell gave a report.

## No public comment.

There was a five-minute recess at 6:13 p.m.

The regular meeting of the Jefferson County Public Utility District No. 1 Board of Commissioners reconvened at 6:18 p.m. Commissioner Dan Toepper took roll call. A quorum was established.

# 7. <u>OLD BUSINESS:</u>

**7.1 EDC Funding.** General Manager Kevin Streett gave an update. At the next ICG meeting there is going to be a discussion about contributions of funding to the EDC (Economic Development Council). There was considerable discussion.

## /Public Comment:

- **Comment:** Business owner and resident of the county does not see any advantage to having the EDC (Economic Development Council). Does not know anything they have done to promote economic development in the county. They are not a government agency. Doesn't think they are doing a particularly good job. There is no accountability with the EDC. For the PUD to raise rates and give the EDC \$30,000 without having any accountability to anyone is wrong.
- **Comment:** Public member spoke as a former business owner in Port Townsend does not support the PUD belonging to the EDC. Would prefer that the PUD put the \$30,000 into inventory. The PUD should have an honored seat at the table.

**MOTION:** Commissioner Jeff Randall made a motion for the Jefferson County Public Utility District No. 1 to commit \$30,000 (Thirty Thousand Dollars) in funds to the Jefferson County Economic Development Council Board and for a period of one year with a seat at the EDC Board table. The PUD will review the performance of the organization with funding being contingent on performance. Commissioner Kenneth Collins seconded the motion. Motion carried with two votes (Commissioner Jeff Randall and Commissioner Kenneth Collins) to pass and one vote (Commissioner Daniel Toepper) to not pass.

**7.2 BPA Fiber Contract Approval.** General Manager Kevin Streett gave a report. This contract is for the dark fiber from BPA (Bonneville Power Administration). It is fiber from Port Angeles to Olympia Substation. The PUD has to purchase the whole distance. It will give the PUD connections at Discovery Bay Substation, Quilcene and Duckabush. There was considerable discussion. Details of discussion can be heard on audio recording at <u>www.jeffpud.com</u>.

**MOTION:** Commissioner Kenneth Collins made a motion that the Jefferson County Public Utility District No.1 Board of Commissioners authorize the General Manager to sign the contract enabling the Jefferson County Public Utility District No. 1 to complete the Bonneville Power Administration fiber project. Commissioner Jeff Randall seconded the motion. Motion carried unanimously.

# 8. <u>NEW BUSINESS</u>:

**8.1 PUD Retail ISP Discussion.** General Manager Kevin Streett recommended that the Jefferson County Public Utility District No. 1 become an ISP (Internet Service Provider) and

went over the steps required to become an ISP.

**MOTION:** Commissioner Kenneth Collins made a motion that the Jefferson County PUD Board of Commissioners support the General Manager in moving forward to seek Internet Service Provider status from both the State of Washington and on a federal level. Commissioner Jeff Randall seconded the motion. There was considerable discussion. Commissioner Jeff Randall called for the question. Motion carried with Commissioner Kenneth Collins voting yes, Commissioner Jeff Randall voting yes, and Commissioner Dan Teopper abstaining.

### **Public Comment:**

• **Comment:** The commissioners did not ask for public comment on this topic and went right to a vote.

Response: Point taken.

**8.2** Commissioners' Communications. Commissioner Kenneth Collins reported his concerns on the lack of a process for responding to emails sent by individuals to all three commissioners. There needs to be a vetting process that involves all three commissioners or a consolidation process involving the PUD's Communications Director who might put together the responses that come into some of the commissioners or all of the commissioners to respond. There was considerable discussion. Details can be heard on audio recording at <u>www.jeffpud.org</u>.

There was consensus among the commissioners to send a request to the staff to provide the BOC with a couple of alternatives of responding to emails sent by individuals based on the discussion at this meeting, and to present this at a future meeting.

- **Comment.** The Jefferson County Board of County Commissioners get a lot of emails sent to them and it goes to all three commissioners. Maybe you should ask them how they deal with it.
- **Comment.** You blew a few of your procedures on public comment before you voted on these items. You say that you allow comment on each item and a person can't comment at the beginning of the meeting on an item that is in the agenda. You have to be consistent with what you do. Allowing public comment is pretty important. **Response:** None.


