3. PRESENTATIONS:

3.1 Pole Attachment Fees. Matt Dobson, Project Manager from FCS Group gave an update on pole attachment fees and cost of service. General Manager Kevin Streett announced that what was presented would be reflected in a resolution to be presented to the BOC at the meeting of 12-8-2020.

No public comment.

3.2 Cost of Service Study: Sergey Tarasov, Project Manager from FCS Group, gave a presentation. Commissioner Kenneth Collins requested benchmarking data. Further details on meeting can be heard on audio recording at www.jeffpud.org.

Public Comment: (abbreviated)

- **Suggestion:** Some consideration be given providing special rates for electric vehicles. This would be in the interest of creating a public benefit and in concert with the PUD's participation in its climate action program,
- **Comment:** Graphs were misleading in the presentation. Opposed to the use of demand rates for residential. Using energy charges is the correct and fair basis for residential rates.
- Comment: Alternative example in presentation showed 19% to 25% increases and charges over the next four years and that looks pretty steep. Will be a pretty hard sell in looking at what the PUD customers were promised when the PUD took over.
- Comment: The 10% increase from BPA. Requested more information on this.
