REVIEW DRAFT ECONOMIC DEVELOPMENT FRAMEWORK: Port Townsend City Manager John Mauro reviewed the draft outline of the Economic Development Framework with the ICG Members who participated in discussion. The members were in favor of forming an Economic Development Framework subcommittee consisting of Administrators, one Elected Official from each agency, and Economic Development Council (EDC) Team Jefferson.

JURISDICTION REPORTS: The Port of Port Townsend, PUD, Jefferson County and City of Port Townsend each provided reports on their respective jurisdictions.

NEXT STEPS AND FUTURE AGENDA ITEMS: Port of Port Townsend Executive Director Eron Berg stated that the Economic Development Council (EDC) was awarded funds to research the Economic Development Framework, which will be helpful in providing baseline data. Member Putney stated jurisdictions should have staff work on the big projects before there is a shortage of workers.
