RESOLUTION NO. 2026-003

A Resolution of the Board of Commissioners of Public Utility District No. 1 of Jefferson County, Washington ("the PUD"), appointing the General Manager as the Certifier and the Finance Director to comply with filing requirements under the Rural Utilities Service (RUS) Loan Program.

WHEREAS, the District has an outstanding loan from the Rural Utilities Service (RUS) which requires the submission of Rural Utilities Service (RUS) form 675; and

WHEREAS, the District must appoint a Certificate of Authority on their behalf, who shall be responsible for submitting and certifying to the Rural Utilities Service (RUS), an agency of the United States Department of Agriculture delivering Rural Development Utilities Programs, any and all data required by Rural Utilities Service (RUS) form 675 and;

WHEREAS, the District must appoint staff to sign the following RUS forms on their behalf, who shall give access to the District's data, as appropriate, to other employees, officers, or contractors of the District, for the purpose of complying with Rural Utilities Service (RUS) form 675.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Public Utility District No. 1 of Jefferson County, Washington that: The District appoints Joseph Wilson, General Manager; Amanda Isaak, Interim Finance Director and Will O'Donnell, Broadband and Communications Director, as the staff allowed to act on the behalf of the District and that shall comply with the Instructions for RUS Form 675 in regard to the use of the government's data collection system.
