RESOLUTION NO. 2026-007

A Resolution of the Board of Commissioners of the Public Utility District No. 1 of Jefferson County, Washington ("the PUD"), authorizing changes to policy for compliance with changes in statute, case law, rulings and decisions.

WHEREAS, the Commission is authorized to set policies for the PUD; and

WHEREAS, it is common for the laws to change either by statute, case law, rulings, or decisions; and

WHEREAS, the Commission recognizes that timely changes to policy are necessary to comply with these changes in law.

NOW THEREFORE BE IT RESOLVED that the General Manager is hereby authorized to modify existing policies and procedures as necessary to address changes in applicable laws, including but not limited to changes in statute, authoritative case law, rulings, and decisions.

BE IT FURTHER RESOLVED that the General Manager will provide updates to the Board of Commissioners as changes are made to policies addressing these changes to the law at future Commission meetings as needed or requested by the Commission.
